[Decomposition of Consumer Sentiment and the Effects of its Cyclical Component](#)

Abstract: Conventional empirical models occasionally incorporate sentiment to explain business cycle movements but rarely distinguish consumer optimism or pessimism from overall sentiment level. In this paper, I decompose consumer sentiment into trends and cycles using various filtering methods, with the cycles representing consumer over-optimism or pessimism. To mitigate discrepancies arising from specific statistical methods, I construct an average cycle based on a suite of five distinct commonly used measures. Using the average cyclical sentiment, I analyze the impact of sentiment on inflation expectations and macroeconomic variables. When using monthly U.S. data from 1978 to 2023, I find that cyclical sentiment significantly impact inflation expectations, unemployment, and industrial production. However, the responses of core CPI inflation and CPI inflation to cyclical sentiment are ambiguous. I also incorporate several additional variables related to personal income, consumption, financial markets, and the labor market to examine their responses to cyclical sentiment. All these variables also exhibit short-lived but significant responses to cyclical sentiment movements.
